As of September 01, 2003, every individual operating a snowmobile in Vermont is required to have personal liability insurance. The minimum required coverage is \$25,000 for one injury or \$50,000 for two or more injuries or deaths with a minimum of \$10,000 property damage. **(The fine for operating without insurance is \$616.00 plus court cost!)** Proof of insurance is NOT required to buy your TMA.
